General Terms and Conditions

- 1. All job tasks are subject to a one-hour billing minimum.
- 2. Time is billed in 15-minute increments and rounded-up to nearest quarter-hour.
- 3. Our operating hours are 9AM 5PM, Monday through Friday, excluding Holidays. Before/After hours herein are defined as any hours outside those stated.
- 4. Time required for loading and pulling items located at our warehouse is chargeable at rates specified.
- 5. Receiving party must be present at the job site to inspect and confirm condition of products upon pickup/delivery.
- 6. For shipments to be received at our facility, please ensure packages are addressed as follows:

- 7. For delivery jobs, Client must complete and provide our Furniture Delivery Information form at least two business days prior to project.
- 8. Jobs requiring a full workday must allow for a 1-hr lunch break for delivery team.
- 9. Cancellations must be in writing and provided to Collectic Home at least two (2) business days in advance.
- 10. Declaration of Value
 - a. Collectic Home's liability is limited to \$.60/lb per article as required by the State of Texas.
 - b. Higher coverage must be specified on our Declaration of Value Form for each individual item and provided at least 24 hrs in advance of project.
- 11. Full Replacement Liability
 - a. \$10.00 per \$1,000.00 of Declared Value with a \$250 deductible.
- 12. Furniture items may exhibit chips, cracks, loose threads, missing parts and other characteristics that may or may not be considered defects. Collectic Home endeavors to inspect each item and handle goods with care, but all characteristics may not always be evident. If it is apparent that an item had inherent, internal or preexisting damage or defects. Collectic Home shall not be held responsible for such damages or defects. Upon Client's request, Collectic Home can arrange for repair at Client's expense.
- 13. The parties hereto agree that any controversy or claim arising out of or relating to services provided by Collectic Home shall be settled by arbitration administered by the American Arbitration Association in accordance with its Commercial [or other] Arbitration Rules, and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.
- 14. All pricing is subject to change without notice. Collectic Home, LLC reserves the right to make adjustments to prices and service offerings for any reason, including but not limited to changing market conditions, availability and operating costs.
